Community resources: The Organization connects leaders in the community to critical information and essential services. Due to COVID-19, the Organization spent a considerable amount of time and resources modeling how direct aid and critical services should be implemented for the Latino community. In 2020, 2,362 members of the community were helped with food baskets, direct financial aid or one-on-one referral services. The Organization reached a total of 32,834 community members with information and programs.

4b (Code:) (Expenses \$ **93,991** including grants of \$) (Revenue \$)

Civic engagement: The Organization educates and mobilizes Latino voters to increase participation in local elections. This includes non-partisan voter registration drives, issue education and Get Out The Vote initiatives. In 2020, 14,272 likely Latino voters were reached by the Organization.

Policy/Advocacy: The Organization trains and mobilizes Latina and Latino leaders to inform public policy and change inequitable systems. The focus is on social justice policy issues, including immigration, healthcare, public education, economic mobility, and more. In 2020, the Organization recorded 1,675 advocacy actions taken by members of the community about important issues like COVID-19, immigration, access to healthcare and others.
